



Staffordshire University Recommend a Friend for UniLife 2018 - Referral Programme

Terms and Conditions

1. The Programme is organised and promoted by Staffordshire University, Marketing & PR, College Road, Stoke-on-Trent ST4 2DE
2. Staffordshire University reserves the right to cancel or amend all or any part of the Programme and/or the Rules without notice for any event that is outside Staffordshire University's reasonable control. Any changes to the Rules, or cancellation of the Programme, will be posted on www.staffs.ac.uk website. It is the responsibility of entrants to keep themselves informed as to any changes to the Rules.
3. Entry to the Referral Programme is open to all applicants who have secured a place at UniLife 2018 and are eligible to join undergraduate study commencing in 2018 or 2019. Entrants must be full time residents of the UK, (including the Channel Islands and the Isle of Man). Proof of eligibility and identity may be requested.
4. Entrants must submit all requested data.
5. The personal data provided will be used for the purposes of administering the Programme and for follow up marketing and communications about studying at Staffordshire University. The form of communication may include (but not limited to) Email, Post, Telephone call, SMS, and advertising via third party digital platforms such as Google, Facebook & Twitter.
6. Entry opens on Monday 2 October 2017 at 9am. Entry closes on Friday 18 May 2018 at 5pm.
7. Maximum 3 recommendations per applicant are permitted.
8. Recommendations will be deemed "successful" if the referred friend applies to UniLife, has their application accepted and attends UniLife in July 2018.
9. Staffordshire University reserves the right to amend these rules or cancel this Programme at any stage, or if circumstances arise outside of its control.

Staffordshire University, its sub-contractors, subsidiaries, agencies and/or any other organisations associated with this Programme cannot accept any responsibility whatsoever for any technical failure or malfunction or any other problem with any server, Internet access, system or otherwise which may result in any entry being lost or not properly registered or recorded.
