All our LLB Law degrees allow successful students to proceed to the next stage of studies to become a Solicitor, Barrister or CILEX Lawyer.

A programme of core modules in the early years of your degree ensures that you have the essential foundations for a wide range of legal subjects.

Our core modules are aligned with subject content in the Solicitors Qualifying Examination which is the route to qualification for solicitors, and are required for entry to training for the Bar after graduating.

In your final year, a wide range of optional modules allows you to choose subjects which will support your individual ambitions. Aspiring advocates might choose to study the Law of Evidence and Mooting to develop their skills in presenting legal arguments in court. If you are interested in a career working directly with lay clients, then Legal Advice

Clinic and Alternative Dispute Resolution modules will enhance your ability to work with clients with a range of legal problems: the Legal Advice Clinic module gives you a unique opportunity to put all your skills into practice as you give advice to real life clients, supervised by lecturers who are solicitors.

Other options allow you to engage with international structures in both Law and Human Rights or to specialise in an area such as Family Law, Employment or Company Law. There is also the opportunity to do research into a legal area of your choosing and to produce an extended piece of work in the form of a Dissertation.

Whatever your interest, you will learn from expert staff with a wide range of academic specialisms and professional experience.
